Sheriff's Media Release

Description of Incident:

The Sheriff's Office asks that all visitors and residents to respect our neighborhoods and beaches during the upcoming July 4th weekend.

The Sheriff's Office, CHP, Cal Fire and State Parks are preparing a comprehensive plan of enforcement for the unincorporated areas for Friday, July 4, 2014 and the days surrounding the holiday. In part, this is a response to a long history of large crowds as well as community input regarding assaults, gang related problems, public intoxication, property damage, disturbance of the peace, fireworks and severe fire danger.

The Sheriff's Office, with the assistance of other agencies such as California State Parks, California Highway Patrol, Cal Fire and local fire agencies will be actively enforcing laws to insure that residents and visitors enjoy a safe holiday experience. In addition to extra staffing for the neighborhoods, and extra patrol officers, officers will be conducting enforcement along North Coast Beaches, Live Oak Beaches, Aptos and Watsonville Beaches, from the border of Monterey County to the border of San Mateo County.

Possession of open containers of alcohol and consumption of alcoholic beverages in public areas that include all beaches is unlawful. In all unincorporated areas of the County possession of **any** fireworks including those designated as SAFE and SANE are unlawful.

A County Ordinance for penalty enhancements during holiday periods makes it a **\$1,000.00** fine for persons cited for fireworks violations, possessing open containers of alcohol in public, consuming alcoholic beverages in public and noise violations between July 2nd and July 6th. Additionally, glass containers, wood pallets, or wood containing nails, unleashed pets and vehicles are prohibited on public beaches.

Parking in many areas including North Coast is restricted after 10 pm. There is no overnight camping in non-designated campgrounds and no overnight camping in the street.

Road Closures

Road closures and a traffic plan with detours will be in effect on Friday, the Fourth of July. Refer to attached list for the specific road closures.

Santa Cruz County Sheriff's Office P.I.O. Sergeant Mitch Medina will be available throughout the Fourth of July (8 am to 8 pm) for press inquiries at 831-212-1608.

- * 1. 7th Avenue and Brommer Street road closure barricades preventing southbound traffic on 7th Avenue, with an officer directing traffic eastbound onto Brommer Street.
- * 2. 7th Avenue and Capitola Road warning sign indicating "Road Closed Ahead" (at 7th Avenue and Brommer Street.)
- ⁹ 3. 7th Avenue and Eaton Street road closure barricades preventing southbound traffic on 7th Avenue, with an officer directing traffic northbound onto 7th Avenue. Eaton Street at 7th Avenue castbound traffic closed.
