<u>Course Title:</u>	PREA
<u>Course Goal:</u>	This course is presented by Correctional Officers who have attended the NCTI PREA Facilitators course. The curriculum is designed to ensure that staff who may have contact with inmates receive office approved training on the prevention and detection of sexual abuse & sexual misconduct. The course utilizes lecture, group work, and group discussion. Staff will also learn how to report PREA allegations, what signs to look for to prevent PREA incidents, and the laws as they relate to sexual misconduct.
